2.3. Other Hazards

Exposure may aggravate those with pre-existing eye, skin, or respiratory conditions. Causes photosensitivity. Exposure to light can result in allergic reactions resulting in dermatologic lesions, which can vary from sunburn like responses to edematous, vesiculated lesions, or bullae. Shows cross-allergenicity with penicillin. Signs and symptoms of exposure – May induce lupus erythematosus. Can cause anorexia, diarrhea, nausea, vomiting. Common adverse reactions are those of hypersensitivity such as skin rashes,

SECTION 4: FIRST AID MEASURES

4.1. Description of First Aid Measures

7.1. Precautions for Safe Handling

Additional Hazards When Processed: Accumulation and dispersion of dust with an ignition source can cause a combustible dust explosion. Keep dust levels to a minimum and follow applicable regulations.
